At New Life Global Network we endeavor to list our Terms & Conditions clearly and transparently. Please note that once you have made your first payment and signed your agreement with any branch of the New Life Global Network, you are bound by the Terms and Conditions following:

在 New Life Global Network,我们有义务公开透明地明确并提供我们的条款与规则。本协议自支付首笔款项并与新生命任何分支机构签立合同后,您需要遵守如下的条款与规则:

MEDICAL医疗方面

Medical Service 关于医疗服务

For those countries where New Life Global Network is not represented by its own clinic and acts as a facilitator between the Intended Parent and the local Partner Clinics/Doctors, New Life Global Network accepts no liability for the performance of the Partner Clinics/Doctors, or for the consequences of any action taken on the basis of information provided by the Partner Clinics/Doctors. The Intended parent is obliged to sign an agreement for the medical service directly with the clinic providing this and the clinic/doctor performing the medical procedure bears full responsibility.



Embryo Transfer 关于胚胎转移

The number of embryos transferred to a surrogate mother /carrier is usually agreed with the Intended Parent in advance and the doctor acts based on his/her consent. New Life Global Network accepts no liability for the decisions of the Intended Parent. For example if the intended parent agrees to transfer more than one embryo, resulting in the surrogate mother pregnant with twins, no selective reduction is performed (unless medically indicated). The Intended parent bears all responsibility for his/her decision regarding the number of embryos transferred. In the interests of the surrogate's well-being and the additional risks a multiple pregnancy poses, New Life does not permit more than 3 embryos to be transferred at a time.

Communication with the Medical Staff 关于与医疗人员的沟通

New Life Global Network accepts no liability for the frequency and mode of communication from the Doctor /medical staff of the partner clinic. Whilst we strive to provide prompt communications, the Doctor /medical staff are often committed to medical procedures during the day, therefore reasonable time should be allowed for obtaining responses to e-mails or phone calls. We are open to share direct contact details of the Doctor/medical staff with our intended parents, where the former agrees, but New Life Global Network cannot be held liable for their delay in response. To encourage quick e-mail feedback and updates, we advise intended parents to directly contact our Follow-up Managers and Patient Coordinators.

Changes in Program Price 关于项目金额的变化

New Life Global Network reserves the right to update changes in the program costs as they occur, unless the contract has been signed and first payment made. Fees quoted at the time of initial consultation may be outdated by the time of deciding to proceed; therefore New Life GN can only offer current program costs. 一旦项目金额发生改变,我们 New Life Global Network 有权利进行更新以及调整(合同已签以及首笔款项已付情况下除外)。前期咨询的报价有可能在项目准备开始的时候发生改变,因为我们 New Life GN 只可以提供最新的项目报价。

Deposits, Payments & Cancellations 关于定金、付款方式&取消

New Life Global Network will require a deposit (the first payment) to secure your booking of an egg donor with full payment to be made according to the payment schedule agreed in advance. All prices and availability of the egg donor are subject to change until we have received the signed agreement. The deposit amount will vary depending on program details. Non-receipt of your Deposit payment, by the stated due date, will result in your booking being cancelled.

Tickets and Accommodation 关于交通费以及住宿费

In very rare occasions the program dates may get changed or the necessity of postponing the program may arise. Therefore all Intended Parents are strictly warned that the tickets they buy must be exchangeable and refundable. The same applies to any arrangements for accommodation. In case the Intended Parents buy the tickets that are nonrefundable and/or not exchangeable New Life Global Network does not bear any financial responsibilities and cannot be kept liable for any actions taken by the intended parents.

Refunds 关于退款

On rare occasions the egg donor chooses not to proceed, most often due to unforeseen personal circumstances. In this instance, alternative options will be offered and discussed at the discretion of the program coordinator. However, if the intended parent prefers to cancel the program and not select a new donor, a full refund of the donor's costs will be provided subsequently. The number of eggs retrieved from a donor cannot be guaranteed. Any previous donation results may not be consistent with each donation cycle. Clients will be informed of the donor's progress under medical stimulation but cannot request a refund for egg numbers not meeting expectations. If it turns to a very rare occasion of Empty Follicle Syndrome (EFS) meaning that no oocytes are retrieved after an adequate ovarian response to stimulation and meticulous follicular aspiration the trail will not be counted. No refund policy is applicable in case of EFS and the Surrogate Mother's preparation/screening/compensation fees will remain chargeable.

一般很少有的情况下捐卵者会临时退缩,很多情况下都是因为一些无法预测的个人因素。若出现如此的情况,我们会提供备有方案并与项目经理进行恰谈。然而,若准父母倾向于取消并不打算挑选新的捐卵者,随后捐卵者的费用将全额退。对于每个捐卵者所取得卵子数量,在此我们不做任何保证。任何前期的捐卵案列并不会跟每一个捐卵周期相一致。我们会及时通知您在医疗刺激下卵妈的过程情况,我们不接受因卵子数量没有达到您事先预期的而要求退款。若出现空卵泡综合症这种特殊的事件,即意味着在足够的卵巢刺激以及卵巢抽吸之后,依旧没有办法提取卵母细胞的情况下,我们是不会将这次尝试包含在内的。然后在这种情况下,一律已交的费用概不退款,然而代母的前期准备费用/筛检/补偿费用仍需支付。

If the intended parent chooses to cancel their program for any reason, no refund can be provided.

Equally, no refunds can be claimed for unsuccessful attempts and completed procedures. Fertility treatments do not offer a guarantee of success and whilst we endeavor to work with every client towards this goal as soon as possible, all intended parents should be prepared for additional attempts if required.

Coverage of Emergency Care Fee 关于紧急护理费用

All expenses associated with any emergency care (medical, non-medical) undertaken for a surrogate mother or a baby encountered from the surrogate having signs of early delivery, actual premature delivery of the baby or any additional medical care (rather than standard one encompassed in the financial annex) shall be covered by the intended parent(s). Here are several examples of the emergency care fee for which should be covered by the parents:

若代孕出现早产的迹象,代母以及宝宝所产生的相关紧急护理费用(医疗/非医疗),宝宝真正早产之后或任何其他的医疗费用(而不是合同里面所注明的标准价格),准父母都需承担并支付。如下列出一些紧急护理费用我们准父母要承担的:

- Medical consultation regarding early (earlier than due date set by the doctor) constriction of the surrogate mother
 - 关于咨询早产事宜(比医生预期的日子要早)
- Medication/procedure for preventing progression of early constrictions 医疗/手续来阻止早产
- Transportation of a surrogate mother /baby to clinic and back 代母/婴儿来回诊所的交通费用
- Transportation of a surrogate mother/baby to another city (for example from Cancun to Tabasco, in case program is done in Mexico 代母/婴儿去另外一个城市的交通费用(例如:在墨西哥执行的项目,从坎昆到塔巴斯科的费用)
- Accommodation and living expanses of a surrogate in other city (for example if surrogate is taken to Tabasco earlier than set date) 代母在另外一个城市的住宿费用以及生活费(例如:代母在预定的日期被提前带到了塔巴斯科)
- Fee for emergency care unit in case baby is born premature and needs extra care 若是早产婴儿则需要额外的照料,则需支付急诊病房的费用
- Fee for invited doctor to get the second medical opinion 若邀请医生再次咨询医疗方面的意见

The similar policy applies to post natal care complications that may occur after delivery and there is a need of additional care to be taken to the Surrogate Mother before she is discharged from the Hospital. 类似条列同样适用于在宝宝出生之后所产生的产后护理并发症,代母在出院之前同样也需要额外的照料。

Usually such emergency fees are payable within a short notice and the immediate actions are expected to be undertaken by the Intended Parents. With purpose the late transfer does not influent on the health status of the SM/baby New Life offers the IPs to deposit the amount agreed with the Agency beforehand. This precaution is mostly actual for those programs when the medical record predicts / estimates the pregnancy to run with certain complications or early delivery to occur.

New Life Global Network is not responsible if the stay of the IPs in the country of program realization is prolonged due to the legal procedures.

In the event of premature delivery the request on farther investigation should be applied within maximum 48 hours. New Life has no rights to act on behalf of the parents in this matter. All expenses should be covered by the Intended Parents on the spot.

Each employee is aware that he/she should not accept program fee payments in cash. Should this ever be requested of you, please inform our head office accordingly.

Discounts 关于折扣

New Life Global Network develops and sets program package prices in every country according to the local jurisdiction and tax regulations. All program prices are fixed and agreed with the local tax authorities.

Waiver of Agency Fee 关于减免中介费

New Life Global Network is represented in multiple countries worldwide. Each branch in a specific country operates under local jurisdiction and follows local regulations. The branches differ from each other in terms of tax code, regulations, program fees, etc. Therefore, no agency fee can be waived whilst moving the program from one branch to another. The full package fee from the newly selected branch will apply. This is

also applicable when the intended parent still has additional attempts remaining with their contracted surrogate mother at a previous branch.

Government actions, war, threat of war, strike, natural or nuclear disasters, quarantine, epidemic, severe weather conditions, change of legislation or similar events beyond our control.

Proof of payment sent must be provided to your Program Coordinator.

Power of Attorney 关于代理权



In the first term of Gestational Carrier pregnancy the Intended Parent (s) is obliged to provide the Pregnancy Care Coordinator with the Power of Attorney authorizing its holder with physical and legal custody of the Child. The document should encompass all rights, including legal and medical that can be associated with the Child. The Intended Parent(s) attorney shall remain liable for all expenses, fees, and costs associated with the surrogacy as delineated under the terms of this Contract. The Power of Attorney will come in force only for the condition if Intended Parent (s) dies while the Gestational Carrier is pregnant.


Flow of Communication 关于沟通流程

In order to facilitate prompt feedback, quality care and clear communication, New Life Global Network has specifically assigned coordinators for each part of the program: from initial contact (introduction and

administrative) to medical process and pregnancy care. The first contact person for any intended parent is a follow up manager who introduces all program details and various options possible via e-mail or phone. After signing the agreement, the next step of the program is managed by a medical coordinator. Once pregnancy is confirmed, the program is managed by your assigned pregnancy care coordinator, who communicates between the intended parent, clinic staff and surrogate mother. All intended parents are requested to address the specific coordinator assigned to each stage of their program, as this allows us to be as efficient as possible.

Since doctors need some time to provide documents of surrogate mother check up to our staff members, pregnancy care reports are usually sent the second day from its completion. If the medical report is done on Friday, please expect it to be provided to you no earlier than Monday.

This made us write this page for the Intended Parents and to make them aware about some kind of cultural particularities in some countries. We would like to suggest the parents about some aspects and advice them how to act in case they are unhappy about anything or encounter some inconveniences.

When we provide the intended parents with the costs of certain services and we have them clearly outlined in our program packages, they are agreed with the provider clinics including IVF clinics, laboratories and delivery hospitals. Same applies to Legal team charges. We have special agreements with them with due costs and they are all aware not to charge anything extra to the Intended Parents. However, in some

countries it is very cultural to ask extra payments for some services. In such occasion, we request the parents to inform us immediately and give more details who asked for additional payment and for which service. We will be able to remind them our agreement and you will be saved from paying extras. We would like to emphasize that in order to receive most affective actions from us, we should be involved from the very beginning.
